STAFFING Anticipated Vacancies – High School Humanities beginning Oct 4 th . Two candidates for Humanities

Teacher have been interviewed with decision pending October 2 nd. Our goal is to have all

positions filled by October 13 th . NMAMA anticipates need for additional FT SPED Staff. Report to follow when available. Advertisements scheduled for Tuesday 9-12-23.

BUILDING HVAC Conditioning in Main Building Update – No updates.

Phones – Gaps in phone coverage being identified and addressed before All Calls and Lock Down

Drills proceed.

UPDATES Humanities Support – NMAMA recognizes Ms. Coates, Ms. Chavez, Ms. Funk, and Ms. McDowell in

supporting students, administration, and the school in their efforts to reconcile grades in HS Humanities.

SEL Grants – NMAMA awarded \$25,000 for SEL (Social Emotional Learning) funds. NMAMA was declined its application for \$125,000 of Wellness Room Funds.

School Discipline – Parents in conflict with school have relocated their students to other schools.

Discipline as a whole has abated in intensity. Behavior Contracts and Improvement Plans have been revised. At the time of this writing, only one student is currently on an Improvement Plan and 0 students are on Behavior Contracts.

Safety Support Zones – No students are currently expected to report to Zones. Earlier student conflict appears to be resolved.

Dignitary Visits – Representative Pamela Herndon visited school SEP 8 and October 3 rd requisitioning documentary capturing how monies are spent to address Mental and Behavioral Health in schools. Currently working with Mr. Conforti to outline project.

School received visit from Valery Ratliff-Parker, Deputy Director of Public Charter Schools of New Mexico.

Technology – Coordinated with Mr. Fayne to put alarms in place with CTE and Portables. New phones ordered to ensure all classrooms have operating phones. New cameras being ordered to address gaps in security.

Discipline Policy – Reviewed by Faculty and Staff who will work with current policy until a new policy is proposed for adoption by Governing Council at future date. Trauma informed practices being considered for implementation by Faculty and Staff as professional development at no cost to school. Discipline Team assembled and meeting weekly.

Shot Clinic – Scheduled for October 31 st, offering Flu and COVID vaccinations from 9 AM to 12 PM.

Lunch Duty Schedule – Revised providing more coverage Before School, during Lunch, and After Business Managers Report Mike – Ill keep my report brief. Reconciled to September 30<sup>th</sup> 2023. This report encompasses that we expect as far as salaries. School count is done at 40<sup>th</sup> day for the 80<sup>th</sup> and120th day will affect your funding for next year.

There was an appropriation for instructional materials this was for just under \$3300.00.

Expenditures if everything is paid off will have \$500,000 available.

Capitol funds take care of all lease payments

There are funds available for board training

Annual audit is happening. Exit conference may be the end of October.
